ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu W.P.(Crl.) No.618 of 2025.

2. The case was registered in Cr.No.619 & 620 of 1999 for alleged offence under 8(C) and 20 (B)(1) NDPS Act. The allegation in this case is that the accused were found to be in possession of 10 gms of prohibited Ganja for their personal use. There is no previous or subsequent case as against the accused. The case is pending at the stage of execution of warrant on the

3. Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the warrant could not be executed, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the proceedings in C.C.No.100092 of 2011 of District Munsif cum Judicial Magistrate Court, Thirukalukundram Taluk, Chengalpattu is quashed and this Sua Motu Transfer Case is disposed of.
