PRAYER

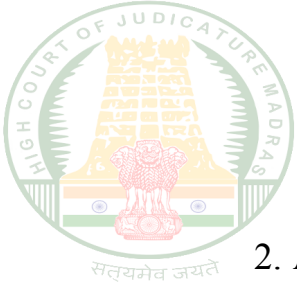
