ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu W.P.(Crl.) No.618 of 2025.

2.The case was registered in Cr.No.2 of 2007 for the alleged offence under Section 324, 457, 307, 34 and 109 of I.P.C. r/w 3 (i) of TNPPDL Act. The mother case in S.C.No.107 of 2010 proceeded further and resulted in an acquittal. The grounds for acquittal also apply to the present accused. The matter has been pending for the execution of warrant.

3.Considering the factual matrix, context of the case, the background of the accused, the reason for absence from her usual place, and the submission that, despite best efforts, the warrant could not be executed, it is evident that even if the accused is brought to face trial, it would impinge upon her right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4.Accordingly, the case in P.R.C.No. 100012 of 2010 of District Munsif Cum Judicial Magistrate Court, Thirukalukundram Taluk,_Chengalpattu, stands quashed. This Suo Motu Transfer Case is disposed of.
