The learned counsel seeks dismissal of the Appeal as settled out of Court.

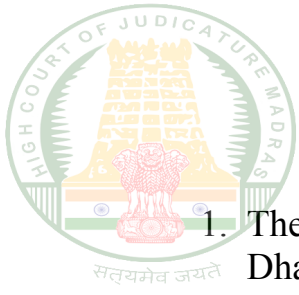
2. Hence the Appeal is dismissed as settled out of Court. There shall be no order as to costs. Consequently, the connected miscellaneous petitions are closed.
