3. Before we proceed further we are constrained to write that the prayer is not happily worded as it reads as follows:

'For the reasons stated in the accompanying affidavit it is humbly prayed that this Hon'ble Court may be pleased to substitute the petitioner herein Legal Heir of original petitioner K.P.Jayaraman as a petitioner and Respondents 5 to 9 in W.P.No.11344 of 2021 on file of this Hon'ble Court and thus render Justice.'

Nonetheless in sum and substance, the aforementioned six legal heirs of Mr.K.P.Jayaraman have to be substituted as writ petitioners in place of lone writ petitioner Mr.K.P.Jayaraman and more importantly, Mr.M.S.Arasa Kumar, learned Government Advocate for Respondents 1 and 3 and Mr.M.Rajamathivanan, learned counsel representing Ms.P.Shanthi, counsel on record for R2 do not oppose the captioned
