The learned counsel appearing for the petitioner would submit that the respondent/husband filed a petition for restitution of conjugal rights before the Subordinate Court, Kanchipuram and the same is pending in H.M.O.P.No.351 of 2023. 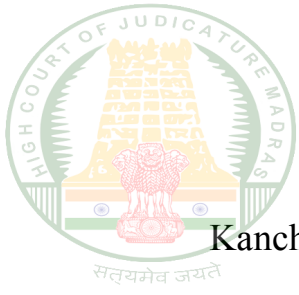
