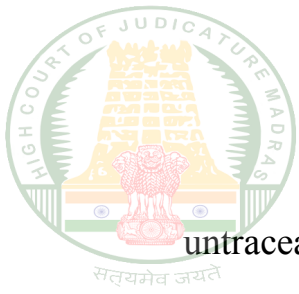

ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu.W.P.(Crl.) No.618 of 2025.

2.The case was registered in Cr.No.616 of 2005 for the alleged offence under Section 420 & 379 of I.P.C. The allegation in this case is that the accused committed theft. It is reported that the stolen property has already been recovered and returned to the defacto complainant. It is also reported that the defacto complainant is not found in the respective address and remain

untraceable. The case is pending from the year 2005 at the stage of execution

of warrant on the accused. It is reported that the accused is involved yet another case in Cr.No.3039 of 2004 for the offence under Section 420 of I.P.C.

3. Considering the factual matrix, context of the case, the reason for absence from his usual place, and the submission that, despite best efforts, the warrant could not be executed, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the proceedings in CC.No.240 of 2012 of XIV Metropolitan Magistrate Court, Egmore Taluk, Chennai, is quashed and this Suo Motu Transfer Case is disposed of.
