The present Writ Petition has been filed seeking a direction to the respondent to consider the petitioner's representation dated 06.03.2025 within the time that may be stipulated by this Court.

3. The petitioner herein is a retired Principal of a Matriculation in Mayiladuthurai. After his retirement, the petitioner having involved himself in the process of research and study relating to treatments and therapies that effectively cure prominent diseases like diabetes, phlegm related illness such as cystic fibrosis etc, had introduced a revolutionary treatment therapy with the name 'Saipathy law of medical science' which is a culmination of Thermo therapy, Chemo therapy and Yoga Therapy. In order to register the above research work done by the petitioner, he had addressed a representation dated 26.03.2025 to the respondent.
