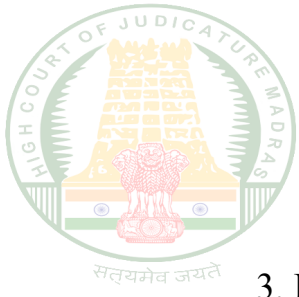

This Criminal Original Petition has been filed seeking for a direction to the learned District Sessions Judge, (Special Court for SC/ST cases) Salem to consider and dispose of the bail application of the Petitioners on merits in connection with the case in Crime No.363 of 2025 on the file of the second respondent herein on the same date of their surrender.

2. In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration of the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to learned District Sessions Judge, (Special Court for SC/ST cases) Salem, to consider the petitioners' bail application, preferably on the same day of their surrender in connection with Crime No.363 of 2025 on the file of the second respondent and pass appropriate orders in accordance with law, after affording due opportunity to the victims under Section 15-A of the SC/ST (POA) Act, 1989. The petitioners shall surrender before the concerned Jurisdictional Court, within a period of fifteen days from the date of the receipt of a copy of this Order.
