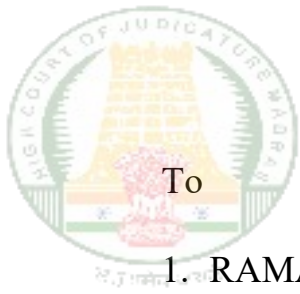
Order
