**ORDER**

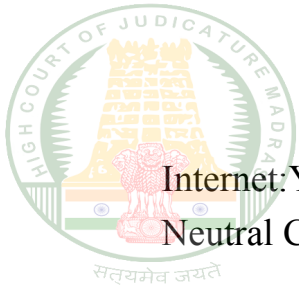
