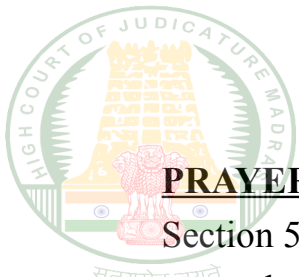

ORDER

3. Accepting the reasons assigned in the affidavit filed in support of these petitions, these petitions are ordered as hereunder:

Thousand only) with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate, Palladam, Tiruppur.
