3. The allegation made as against the petitioner/A1 is that in the name of 13 fictitious persons, she availed 13 loans by submitting fake identity cards and pay certificates. A2 has sanctioned the loans in connivance with A1. The allegations made as against the petitioner are serious in nature. In such view of the matter, this Court is not inclined to quash the final report at this stage.
