2. This case is registered in Crime No. 577 of 2009 for alleged offences under Section 397 of Indian Penal Code, 1860. The incident occurred on in the year 2009. The mother's case proceeded further and resulted in an acquittal. The grounds for acquittal also apply to the present accused. The matter has been pending for the execution of the warrant since 2010.

3. Considering the factual matrix, the context of the case, the background of the accused, the reason for his absence at his place of residence, and the submission made that, despite best efforts, the warrant could not be executed, it is clear that even if the accused faces trial, no useful purpose would be served.

4. Accordingly, the case in P.R.C.No. 93 of 2024 on the file of VIII Metropolitan Magistrate Court, George Town Taluk, Chennai shall stand quashed and this Sua Motu Transfer Case stand disposed of.
