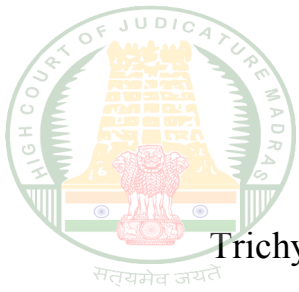
TERMS OF SETTLEMENT
