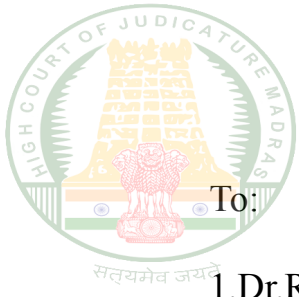
3. In view of the same, this Contempt Petition is closed.
