To set aside the Suomoto docket order dated 26.05.2025 in M.C.No.648 of 2024 passed by the Honble I Additional family Court, Chennai.

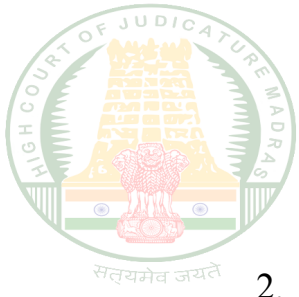
