In order to survey the said land, though the petitioner submitted the aforementioned application before the respondents, so far they did not take any step to survey and demarcate the aforementioned property. Hence, this writ petition.

4. In view of the above, the fourth respondent is directed to survey the aforesaid property based on the title deed produced by the petitioner, after issuance of notice to the adjacent land owners and counter parties, if any, and to serve the survey report to the petitioner within a period of six weeks from the date of receipt of this order. It is made clear that, if the surveyor concerned is obstructed by third parties while surveying the subject land, the said surveyor can approach the jurisdictional police seeking police aid and on such request, the jurisdictional police shall provide adequate police protection to the surveyor.
