**ORDER**

The present Writ Petition has been filed for an issuance of a Writ of Mandamus directing the respondents 1 and 3 to take appropriate department actions as against the 4<sup>th</sup> respondent and to consider the representation of the petitioner dated 17.10.2024

2. When the petition is taken up for hearing, the learned standing counsel appearing for the respondents has produced a Memorandum No.PAG(Audit-II) TN&PY/Legal Cell Misc./2024-25/154 dated 08.01.2025 indicating that already appropriate action has been taken, therefore, pleaded to dismiss the petition as infructuous . Further the said Memorandum is hereby extracted as follows:-

*“It was brought to the notice of Administration that a Summon dated 18.10.2024 was addressed to Shri S.Edward Daniel Chandrasekar, Senior Audit Officer, BO-Puducherry, from the Dhanvanthri Police Station, directing the official to appear before the Inspector, on 19.10.2024 at 11.00 AM, based on a complaint from one Ms.Merlin Joe, Treasurer, North Tamil Conference.*

In view of the above, since the prayer in the Writ Petition to direct the respondents 1 and 3 to take appropriate departmental action against the 4<sup>th</sup> respondent has been duly complied with, the present Writ Petition is dismissed as infructuous. No costs.
