Rs.2,00,000/- to the credit of STC No.261 of 2016 on the file of the learned

Judicial Magistrate, Fast Track Court, Magisterial level, Ambattur within a

period of three weeks from the date of receipt of a copy of this order. On such

payment made by the petitioner, the defacto complainant is permitted to

withdraw the same on proper identification of the proof. Except the above said

modification, other conditions in the said order remains intact.

3.This Criminal Original petition is accordingly ordered.
