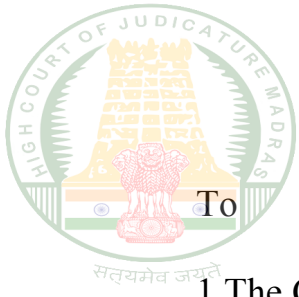

It is made clear that the Court has not made any observation with regard to the merits of the petitioner's claim.
