ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu.W.P.(Crl.) No.618 of 2025.

2.The case was registered in Cr.No.444 of 2019 dated 23.08.2019 for the alleged offence under Section 379 of Indian Penal Code, 1860. The allegation in this case is that the accused committed a theft of motor cycle. It is reported that the stolen property has already been recovered and returned to the defacto complainant. Further, it is submitted that the accused has been regularly attending the Court and there is no previous or subsequent case as against the accused. The defacto complainant is present before the Court and has stated that he does not want to pursue the case any further.

4. Accordingly, the case in C.C.No.235 of 2016 on the file of Judicial Magistrate Court No.I, Krishnagiri Taluk, Krishnagiri shall stand quashed and this Sua Motu Transfer Case stand disposed of.
