This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu.W.P.(Crl.) No.618 of 2025.

2. This case is registered in Crime No.663 of 2006 for alleged

offences under Section 341, 427, 392, 397 and 506(ii) of Indian Penal Code, 1860. The incident occurred on in the year 2006. The mother case proceeded further and resulted in an acquittal. The grounds for acquittal also apply to the present accused. The matter has been pending for the execution of the warrant since 2006.

3. Considering the factual matrix, the context of the case, the background of the accused, the reason for his absence at his place of residence, and the submission made that, despite best efforts, the warrant could not be executed, it is clear that even if the accused faces trial, no useful purpose would be served.

4. Accordingly, the case in P.R.C.No. 3 of 2018 on the file of VIII Metropolitan Magistrate Court, George Town Taluk, Chennai shall stand quashed and this Sua Motu Transfer Case stand disposed of.
