Prayer: Writ Petition is filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus, calling for the records of the respondents, especially the order of the 2nd respondent dated 30.04.1997 under section 9(5) vide Na.Ka.3402/96/A1 and notice dated 25.09.1998 under section 11 (5) of the Tamil Nadu Urban Land (Ceiling and Regulation) Act, 1978, in respect of lands in Survey Nos. 37/4A, 37/5, 37/4B, 43/1A3, 43/1A4 and 42/1A, measuring an extent of 3,450 sq.mts. of Pandeewaram Village, Ambattur Taluk, Tiruvallur District and quash the same and treat the proceedings as abated under Section 4 of the Tamil Nadu Urban Land (Ceiling and Regulation) Repeal Act, (Act 20 of 1999) so as to enable the 3rd respondent to correct the entries in their records showing the name of the petitioner as owner of the land in the said survey nos. 37/4A, 37/5, 37/4B, 43/1A3, 43/1A4 and 42/1A of Pandeewaram Village.
