ORDER

When the matter was taken up for consideration, the learned Standing Counsel appearing for the respondents fairly submitted that in the instant case, disciplinary action has not yet been initiated. Further, the 1st respondent shall pass final orders on merits and in accordance with law, as expeditiously as possible, of course, after affording an opportunity of hearing to the petitioner.
