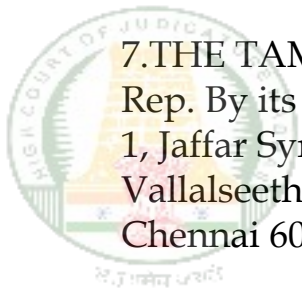

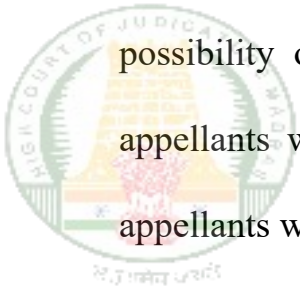

COMMON JUDGMENT

and
R.SAKTHIVEL, J.

On overall reading of the interim order impugned before this Bench in general and paragraph No.2 in particular, we are of the view that the learned Single Judge had only recorded his *prima facie* view for the purpose of relegating the parties to explore the



possibility of an amicable settlement. However, the learned counsel appealed the appellants would submit that the observations in paragraph No.2 may cause prejudice to appellants while the matter is disposed of finally.
