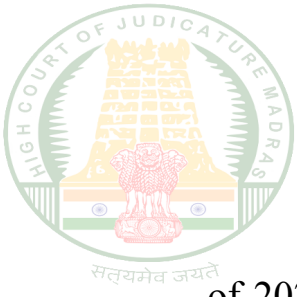

The transfer petition is filed to withdraw and transfer OP.No.284 of 2024 pending before the Family Court, Sivagangai to III Additional Principal Judge, Family Court, Chennai to take up along with MC.No.606 of 2024 pending before the III Additional Principal Judge, Family Court, Chennai.

2. The counsel for the petitioner has served the learned counsel for the respondent appearing in the Trial Court and has also filed a memo on the file of the Family Court informing the Court as well as the respondent about the filing of the transfer petitioner and the fact that notice has been issued. 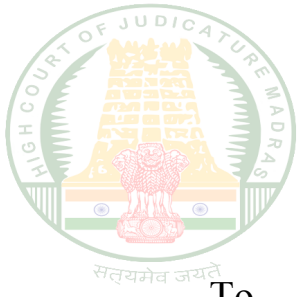
