At the outset, counsel stated that for the same relief, i.e., challenging the intended sale, an application has been filed before the Debts Recovery Tribunal.

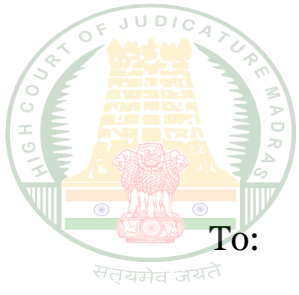
Therefore, allowing petitioner to pursue that application, we dismiss the writ petition. There shall be no order as to costs. Consequently, interim applications stand closed.
