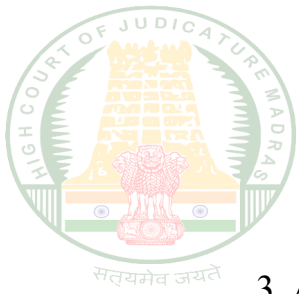

If the petitioner claims himself to be a devotee and more interested in the Temple, it is for him to file necessary suit for framing scheme before the Trial Court. Let the Trial Court decide how the Temple administration and festival be conducted by framing necessary scheme. Accordingly, this petition is dismissed.
