This matter is posted today before this Court under the caption 'For Being Mentioned' at the instance of the learned counsel for the petitioner.

2. Learned counsel for the petitioner submitted that this Court, by an order dated 06.10.2025 has modified the bail condition to the petitioner in Crl.M.P.No.18415 of 2025 in Crl.O.P.No.18638 of 2025. He further submitted that in the said order, in paragraph No.3 in the third line, it is wrongly typed as “... the petitioner shall report before the respondent police once in a week at 10.30 a.m., for a period of four weeks **until further orders....**” instead of “.... the petitioner shall report before the respondent police once in a week at 10.30 a.m., for a period of four weeks ...”.
