his arrest in Crime No.265 of 2025 on the file of the respondent police  
pending investigation.

**ORDER**

The petitioners, who apprehend arrest for the alleged offence under  
Sections 294B and 118(1) of BNS and Section 4 of TNPHW Act, in Crime  
No.265 of 2025, on the file of the respondent police seek anticipatory bail.

2. The allegation against the petitioners is that during temple festival,

there was a wordy quarrel between the defacto complainant and the petitioners. Due to which, the petitioners have abused and assaulted the defacto complainant with stick and caused injuries and also tore the clothes of the defacto complainant. Hence, the present case.

3. The learned counsel appearing for the petitioners submitted that the the petitioners are innocent persons and they have not committed any such offence as alleged by the prosecution. He further submitted that the injured was discharged from the hospital. Hence, he prayed to grant anticipatory bail to the petitioners.

4. The learned Government Advocate (Crl. Side) appearing for the respondent police reiterated the prosecution case and reported that injured was discharged from the hospital. He further reported that there is no previous case against the petitioners. However, he opposed to grant anticipatory bail to the petitioners.

5. Heard both sides and perused the materials available on record.

6. Considering the facts and circumstances of the case, and the submissions made by both counsel, and taking note of the fact that injured was discharged from the hospital and that there is no previous case as against the petitioners, I am inclined to grant anticipatory bail to the



petitioners, subject to certain conditions. .

7. Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on their appearance within a period of fifteen (15) days from the date on which the order copy made, before the learned **District Munsif-Cum-Judicial Magistrate Court, Cheyyur** on condition that each of the petitioners shall execute separate bonds for a sum of **Rs.15,000/- (Rupees Fifteen Thousand only) with two sureties** each for a like sum to the satisfaction learned Magistrate concerned, and on further condition that:

(a) If the petitioners fails to surrender before the concerned Magistrate within a period of fifteen (15) days from the date of receipt of a copy of this order, this order shall stand automatically cancelled;

(b) The sureties shall affix their photographs and left thumb impression in the application for surety ship (Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of identify proofs to ensure their identity;

(c) **The petitioners shall report before the respondent police everyday at 10.30 a.m., for a period of one week and thereafter, as and when required for interrogation;**

(d) On breach of any of the aforesaid conditions, the

learned Magistrate/Trial Court is entitled to take appropriate actions against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on anticipatory bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji v. State of Kerala [(2005) AIR SCW 5560];***

(e)If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of BNS Act.
