ORDER

2. When the matter came up for admission on 06.01.2025, I called for a report from the learned II Assistant Judge, City Civil Court, Chennai to state as to how long he requires to dispose of O.S.Nos.3626, 2248 & 2907 of 2023.

3. The learned II Assistant Judge, City Civil Court, Chennai has sent a report stating that O.S.Nos.3626, 2248 & 2907 of 2023 are listed on 28.01.2025. In O.S.No.3626 of 2023, I.A.Nos.14, 16 & 17 of 2024 are pending for orders and I.A.Nos.18 & 19 of 2024 are pending for filing counter by the 1st respondent.
