This writ petition has been filed for direction to the third respondent to submit the report called for by the 2nd respondent in Letter Na.Ka.No. 3588/ 2023 A3 dated 15.11.2023 with regard to cancellation of patta standing in the name of Sagar Banu and Sarfudeem in respect of TS No. 3093/ 5 and 3158/6B in Kancheepuram Town and Taluk, District.

2. Heard, the learned counsel appearing on either side.

3. It is seen that the petitioner submitted representation to cancel the patta issued in respect of the subject land. On receipt of the same, the second respondent directed the third respondent to submit report. So far, the third respondent did not submit any report.
