COMMON ORDER

These petitions have been filed to extend the time for complying with the conditional order dated 20.06.2024 in CrI OP No14475 of 2024 and order dated 05.06.2024 in CrI.OP No.12867 of 2024 respectively.

2.The learned Government Advocate (CrI.side) appearing for the 1st respondent police vehemently opposed the petitions on the ground that the petitioners are subsequently involved in another offence and they were also arrested and the prosecution has also moved the petition for cancellation of bail.

3.The learned counsel for the intervenor has reported that the petitioners have approached the Hon'ble Supreme Court and filed a SLP challenging the original order which directs the petitioners to deposit amounts and the same is also dismissed and thereafter they have filed modification application and the



same was also dismissed, hence he opposed.
