2. The petitioner seeks for a direction to produce her sister Sumithra who is mentally ill aged 37 years. According to the petitioner, her sister went missing from 09.09.2022, despite registration of FIR in Cr.No.679 of 2025 under women missing, her sister is not secured.

The learned Additional Public Prosecutor, on instructions, submitted that previously also, the petitioner's sister went missing, FIR has already been registered, thereafter, she was secured and handed over to the petitioner, once, again she is missing, they will take all earnest effect to secure petitioner's sister.
