Considering the nature of allegation, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, warrant could not be served, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the case in CC.No.1850/2018 on the file of the VIII Metropolitan Magistrate Court, George Town Taluk, Chennai stands quashed. This Suo Motu Transfer Case is disposed of.
