rectified and the election is conducted in a fair and transparent manner in accordance with the by-laws of the association by considering the petitioner's representation dated 20.09.2023.

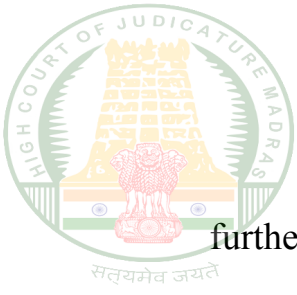
