ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu W.P.(Crl.) No.618 of 2025.

2. The case was registered in Cr.No.1058 of 2021 for the alleged offence under Section 457 and 380 of Indian Penal Code, 1860. It is reported that the stolen property has already been recovered and returned to the defacto complainant and there is no previous or subsequent case as against the

accused. Further, it is submitted that the case is presently pending at the stage of warrant. The defacto complainant is not residing at the given address and remains untraceable till date.

3. Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the warrant could not be executed, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4. Accordingly, the case in C.C.No. 667 of 2022 of XV Metropolitan Magistrate Court, George Town Taluk, Chennai shall stand quashed and this Suo Motu Transfer Case stand disposed of.
