2. Heard the learned counsel appearing on either side and perused the materials available on record.

Without expressing any opinion on the merits of the writ petition, the respondent is directed to consider the online application of the petitioner dated 30.08.2025, seeking sub-division and issuance of a separate patta in respect of the subject property, and after conducting an enquiry by issuing notice to the petitioner and the counter parties, if any, and affording them a personal opportunity of hearing, to pass appropriate orders on merits and in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.
