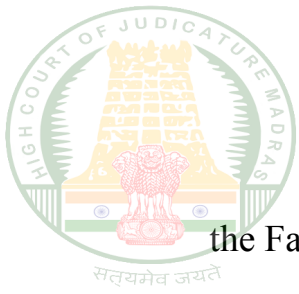

b)The petitioner has to travel to Karur for every hearing, since the matter is pending before the Family Court. The petitioner is an Advocate. On account of her family and health issues she is not able to practise as before. Therefore, she is entirely depending on her aged parents for maintenance.

c)The respondent is not giving any maintenance to the petitioner.
