2. Heard the learned counsel on both sides.

3. The learned counsel appearing for the petitioner would submit that the respondent/husband filed HMOP No.125 of 2024 before the Sub-Court, Uthangarai, Krishnagiri seeking for divorce and the same is pending before it. The petitioner is staying at Dharmapuri and the Sub-Court Uthangarai is around 60 Kilo Meter from her residence which will be very difficult to travel from Dharmapuri to Uthangarai for attending the case.
