ORDER

The petitioner has been granted anticipatory bail for the offences punishable under Sections 294(b), 506(i) of IPC read with Section 4 of the Tamil Nadu Prohibition of Charging Exorbitant Interest Act, 2003, in Crime No.508 of 2025. Thus, the petitioner seeks relaxation for the condition imposed in para 8(c) “the petitioner shall report before the respondent police daily at 10.30 a.m., until further orders” in Crl.O.P.No.21440 of 2025 dated 04.09.2025.

2. The learned Government Advocate (Crl.Side) appearing for the respondent police submitted that the petitioner has been complying with the condition regularly.

3. Considering the submissions of both sides and the nature of offence, the condition imposed in para 8(c) in Crl.O.P.No.21440 of 2025 dated 04.09.2025, “*the petitioner shall report before the respondent police daily at 10.30 a.m., until further orders*” is **relaxed**. The other conditions shall remain unaltered.
