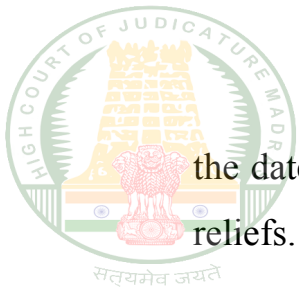

2. Heard Mr.C.Umashankar, learned counsel appearing for the Plaintiff and Mr.M.Selvam, learned counsel appearing on behalf of Mr.P.Thirumalaivasan, learned counsel appearing for the sole defendant.

Today, when the applications in the Suit were listed for hearing, the learned counsel appearing on behalf of the defendant had filed a Memo indicating the admission of liability on behalf of the defendant. The said Memo had been also signed by the Director of the defendant.
