This petition has been filed seeking a direction to the respondents to produce the petitioner's daughter Revathi aged about 19 years, before this Court and set her liberty.

2. It is the case of the petitioner that the petitioner's daughter went missing since 30.07.2025 and not returned to house, therefore, he gave a complaint. FIR was registered in Cr.No.98 of 2025, however, the police have not secured the petitioner's daughter.

3. Today, Mr.K.Chinnasamy, SSI, Sirupakkam Police Station, Cuddalore District is present and produced the petitioner's daughter, Revathi, aged about 19 years before this Court.
