ORDER

(Order of the Court was made by S.M.SUBRAMANIAM, J.)

The writ of habeas corpus has been instituted to direct the respondents 1 and 2 to produce the minor detainee namely M.Kavitha, aged about 16 years.

2. The Sub Inspector of Police – G.Selvam and Kanagaparam (W-Grade I 528), Thirukovilur Police Station, Kallakurichi secured the minor detainee from Bangalore and produced before this Court.

3. We have examined the detainee. She is a minor. She went along with her friend to Bangalore. At present, the minor detainee states that she is willing to stay along with her mother.

4. The learned Additional Public Prosecutor would submit that criminal case has been registered against one Mr.Ayyappan under the Protection of Children from Sexual Offences (POCSO) Act.
