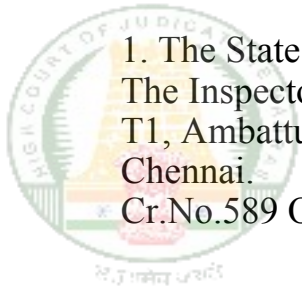
2.Heard the learned Counsel for petitioner.
