ORDER

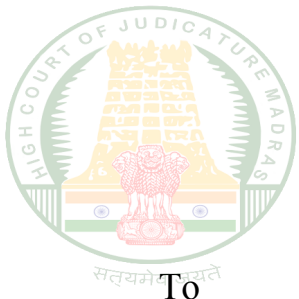
The learned counsel appearing for the petitioner sought permission of this Court to withdraw this Writ Petition and he has also made the following endorsement to that effect:
