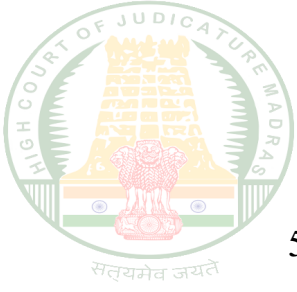
ORDER

6. With the above directions, this Criminal Original Petition is disposed of.

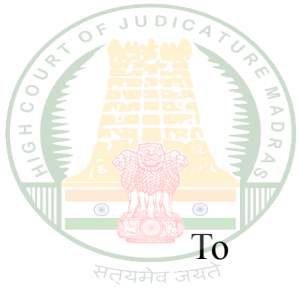
