The said amount shall be paid by the applicant within a period of two weeks from the date of receipt of a copy of this order.

3. Since the respondents have been duly served with the notice in this application and since the vehicle has already been repossessed, nothing survives for further adjudication in this application. Accordingly, this Application is closed.
