WEB COPY The petitioner, who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 318(4) and 316(2) of Bharatiya Nyaya Sanhita (BNS), 2023 (Sections 406 and 420 of IPC) in Crime No.Not Known of 2025, seeks anticipatory bail.

2. The learned Government Advocate (Crl.Side) on instructions submitted that a petition enquiry is pending and the First Information Report has not been registered.

3. In view of the same, the respondent shall conduct and conclude the enquiry within a period of three weeks from today. If the petitioner's appearance is required, the respondent shall issue a notice under Section 35 of BNSS, 2023 and on such notice, the petitioner shall appear before the respondent. Till the conclusion of the enquiry, the respondent police shall not arrest the petitioner.

4. With the above directions, this Criminal Original Petition is disposed of.
